The Lodge shall not make arrangements to pay anyone for assisting in the details of any event. This should all be on a voluntary basis from the membership.

With the exception of the bid for the Jack and Jill and Golf Tournament, all bids for the following year must be in by the October State Convention, along with a floor plan of the room that is to be used for event. The Association Chairman along with a Sports Committee member will investigate to ensure the Lodge meets the necessary requirements for the tournaments they are bidding.

The bid for the Jack and Jill Pool and Golf Tournament must be submitted by July 1st and will be awarded by August 1st. The committee's recommendations for all remaining tournaments will be forwarded to the FBMA Executive Board. The Executive Board will award the remaining tournaments on or before January 1st, of the year they are to be played.

Only members of Lodges and/or Chapters in the FBMA will be allowed to play in any state or regional tournament. All participants must show valid photo ID/proof of age and a valid Moose membership card of the lodge or chapter they represent.

Only Lodges in good standing with the FBMA will be considered for a tournament. **The Lodge must be in good standing with the FBMA in order for its members to be eligible for competition.**
